The Board of Election Commissioners of Faulkner County, Arkansas, do hereby give notice that an election shall be held on May 13, 2025, for the Annual School Election, pursuant to Arkansas Code §7-5-202, for all eligible voters.

A list of election officials appointed to conduct this election will be posted for public viewing at the Faulkner County Clerk's Office no later than April 14, 2025. Any objections to appointed election officials shall be made in writing to the Faulkner County Election Commission, 801 Locust St, Conway, AR, 72034. An objection that an official is a spouse of a county election commissioner, a county party chair, or a spouse of a county party chair must be filed within 7 days of April 14. An objection that an official is married to a candidate or related to a candidate within the second degree of consanguinity must be made within 10 days of April 14.

As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 38.1 mills includes 25.0 mills specifically voted for general maintenance and operation and 13.1 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 38.1 mills represents the same rate presently being collected.

Michael; **42.0 Mill School Tax:** The total rate proposed above includes the uniform rate of tax to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. The total proposed school tax levy of 42.0 mills includes 27.50 mills specifically voted for general maintenance and operation and 14.50 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 42.0 mills represents the same rate presently being collected.

**Mayflower School District: School Board Zone 1:** Pat Raney; **40.10 Mill School Tax:** The total rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 40.10 mills includes 25.0 mills specifically voted for general maintenance and operation and 15.10 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 40.10 mills represents the school tax currently being levied.

**Mount Vernon/Enola School District: School Board Zone 4:** Graham Peterson; **41.5 Mill School Tax:** The total tax rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 41.5 mills includes 25.49 mills specifically voted for general maintenance and operation and 16.01 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the

District for other school purposes. The total proposed school tax levy of 41.5 mills represents the same rate presently being levied.

**Vilonia School District: School Board Zone 1:** Kent Charles; **Schol Board Zone 2:** Jack Martin; **39.70 Mill School Tax:** The total rate proposed above includes the uniform rate of tax (the "Statewide Uniform Rate") to be collected on all taxable property in the State and remitted to the State Treasurer pursuant to Amendment No. 74 to the Arkansas Constitution to be used solely for maintenance and operation of schools in the State. As provided in Amendment No. 74, the Statewide Uniform Rate replaces a portion of the existing rate of tax levied by this School District and available for maintenance and operation of schools in this District. The total proposed school tax levy of 39.70 mills includes 25.0 mills specifically voted for general maintenance and operation and 14.70 mills voted for debt service previously voted as a continuing levy pledged for the retirement of existing bonded indebtedness. The surplus revenues produced each year by debt service millage may be used by the District for other school purposes. The total proposed school tax levy of 39.90 mills represents the same rate presently being collected.
