The Last Day to Register to Vote is Monday, October 20, 2025.

To request an absentee ballot, contact the County Clerk's Office. 801 Locust St, Conway, AR. 501-450-4909. Office Hours are Monday – Friday 8:00 a.m. – 4:30 p.m.

Absentee ballots will be processed and canvassed beginning November 12, 2025, and will continue each day after as needed. Absentee ballots will be opened and canvassed on November 18, 2025.

The Greenbrier School District will conduct a special election to maintain the current annual ad valorem property tax rate. Pursuant to Act 399 of 2025, the election will be held by the appointment of a qualified elector. No polling sites will be opened, and only the appointed qualified elector is eligible to vote in the election.

All election processes listed below will be conducted at the Faulkner County Election Commission Annex, 844 Faulkner St, Conway, or Faulkner County Courthouse 801 Locust St, Conway.

Any objections to appointed election officials shall be made in writing to the Faulkner County Election Commission, 801 Locust St, Conway, AR, 72034. An objection that an official is a spouse of a county election commissioner, a county party chair, or a spouse of a county party chair must be filed within 7 days of October 19. An objection that an official is married to a candidate or related to a candidate within the second degree of consanguinity must be made within 10 days of October 11.
